Navodaya Vidyalaya Samiti, an autonomous body under Ministry of Education, Govt. of India allotted a Jawahar Navodaya Vidyalaya for Pathanamthitta District, was started functioning in Vechoochira, Mannadisala in January 1987.

Accordingly Govt of Kerala allotted 23 acres of Land for starting the Vidyalaya at Mannadisala, Vechoochira, Pathanamthitta Dist.

The Vidyalaya is affiliated to Central Board of Secondary Education, Delhi and prepares students to appear in the All India Secondary School Examination and All India Senior School Certificate Examination of the Board.

नवोदय विद्यालय समिति, शिक्षा मंत्रालय, भारत सरकार के अधीन एक स्वायत्त निकाय है। भारत सरकार ने पथानमथिट्टा जिले के लिए एक जवाहर नवोदय विद्यालय आवंटित किया, जो जनवरी 1987 में वेच्चूचिरा, मन्नदिसाला में काम करना शुरू कर दिया।

जबकि स्कूलों में शिक्षा निःशुल्क है जिसमें भोजन और आवास, वर्दी और पाठ्यपुस्तकें शामिल हैं, रुपये की राशि। विद्यालय विकास निधि के लिए केवल कक्षा IX से XII के छात्रों से 600/- प्रति माह एकत्र किया जाता है। हालाँकि, एससी/एसटी वर्ग के छात्रों, सभी छात्राओं और वे छात्र जिनकी पारिवारिक आय गरीबी रेखा (बीपीएल) से नीचे है, को छूट दी गई है। छूट प्राप्त श्रेणी के अलावा अन्य सरकारी कर्मचारियों के बच्चों के संबंध में (कक्षा छठी से आठवीं के छात्र, सभी एससी/एसटी और छात्राएं और बीपीएल परिवारों के बच्चे) विकास निधि से रु. 1500/- प्रति माह या वास्तविक बच्चों की शिक्षा भत्ता लिया जाएगा। माता-पिता द्वारा प्रति माह जो भी कम हो प्राप्त होगा। हालाँकि, वीवीएन प्रति छात्र प्रति माह 600/- रुपये से कम नहीं होगा।

Navodaya Vidyalaya Samiti, an autonomous body under Ministry of Education, Govt. of India allotted a Jawahar Navodaya Vidyalaya for Pathanamthitta District, was started functioning in Vechoochira, Mannadisala in January 1987.

While education in the schools is free including board & lodging, uniform and textbooks, a sum of Rs. 600/- per month is collected only from the students of Classes IX to XII towards Vidyalaya Vikas Nidhi. However, students belonging to SC/ST categories, all Girl students and the students whose family income is below poverty line (BPL) are exempted. In respect of wards of Government employees other than exempted category (Students of classes VI to VIII, all SC/ST & Girl students and wards of BPL families) Vikas Nidhi will be charged @Rs.1500/- per month or actual children education allowance received by the parent per month whichever is less. However, VVN shall not be less than Rs.600/- per student per month.
