The above sanction is subject to fulfillment to following condition:-

1. The grant for recognition is not expendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The School shall abide by the provisions of Right of Children to Free and compulsory Education Act,2009 (annexure I) and Right of Children to Free and compulsory education Rules ,2010(annexure II).
3. The school shall admit in class 1(or in pre-school, as the case may be), to the extent of % of the strength of that class, Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion.
4. For the children referred to in paragraph 3, the school shall be reimbursed in accordance with the provision of sub-section (2) of section 12 Act to received such h reimbursements school shall maintain a separate bank account.
5. The Society /School shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
6. The school shall not deny admission to any child for lack of age of proof shall adhere to the provisions of section 15 of the Act. The school shall ensure;
 - a. No. child admitted shall be held back in any class or expelled from school till the completion of elementary in a school;

- b. No. child shall be subjected to physical or mental harassment.
- c. No. child is required to pass any board examination till the completion elementary education;
- d. Every child completing elementary education shall be awarded a certificate as laid down under rule 25.
- e. Inclusion of students with disabilities / special needs as per provision of the Act.
- f. No. part of the school building or campus can affect the safety of children while attending school.
- g. The teachers are recruited with minimum qualification as laid under section 23(1) of the Act provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualification within period of 5 years.
- h. The teacher performs its duties specified under section 24(1) of the Act and
- i. The teachers shall not engage himself or herself for private teaching activities.
7. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
8. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

13. The accounts should be audited and certified by a chartered accountant and proper accounts statements should be prepared as per rules. A copy each of the statements of accounts should be sent to the District Education Officers every year.

15. The school furnishes such reports and information as may be required by the Director of Education /District Education Officers from time to time and complies with such instructions of the Appropriate Government/Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.
