1. Tenders should be sent under strong sealed cover marked as  
The tenders shall be submitted according to the terms and conditions specified in paragraphs 2 to 14 unless specified otherwise in the tender, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.
2. The rates should include excise duty, Income tax any other taxes, GST or imposition whatever liable in respect of the supplies and FOR at JNV Kottarakara, Kollam District. GSTIN should invariably be quoted in the tender form/schedule.
3. *There should not be any over writing or corrections in the tender. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of the attested signature the tender is liable to be rejected.*
4. The undersigned does not bind himself to accept the lowest tender and reserves the right to accept the tender in whole or in part, i.e., with respect to all the articles mentioned in the attached statement or in respect of anyone or more than one article specified in the attached statement as the may decide.
5. On acceptance of the tender it will become a contract and the contractor shall be bound by the terms and condition of the tender.
6. The tenderer shall deposit Bid security (earnest money) as specified against each work in the detailed tender notice No. 2-27/JNVK/2019-20/58 dated 6/5/2019 along with the tender by Banker's cheque/Demand draft drawn in favor of the JNV/Kollam payable at Indian Bank, Kottarakara or any Nationalised Bank at Kottarakara or through electronic mode by RTGS/NEFT to vidyalaya account No. 481370926 in Indian Bank, Kottarakara branch ( IFS Code No. IDIB000K075) which shall be refunded in the event of rejection of the tender. The Bid security(EMD) will be forfeited in the event of failure to comply with contract. In the event of the tender being accepted, the Bid Security(EMD) will be adjusted towards Performance Security(security deposit) which shall be payable at the rate mentioned below:

**Performance security (Security deposit) @ 10% of the total amount.** If the contractor is not agreeable to pay security deposit, the reasons therefore should be specified and the undersigned reserves the right to accept or reject the request.

7. If the contractor fails to supply the articles within the time stipulated in the letter of acceptance by the undersigned, the undersigned shall be at liberty to purchase the articles from the market or get the rest of the contract completed by any other person or firm and the difference of price, if any, shall be deducted from the earnest money/security deposit and in case any amount in excess of the security deposit is paid by the undersigned the contractor shall be liable to pay this amount.
8. The quantity of articles indicated in the attached statement may be increased or decreased at the discretion of the undersigned without assigning any reason.
9. Prior to acceptance of the tender, the undersigned reserves the right to call for sample(s) or demonstration and the contractor shall be liable to produce the sample(s) or give the demonstration free of cost.
10. In the event of acceptance of the tender and placing of the order for purchase, the articles ordered for would be subjected to an inspection by the undersigned or her representative and are liable to be rejected if the articles supplied are not according to approved samples or do not conform with the specification prescribed for.
11. The rates quoted by the contractor shall hold good up to 31.03.2020. **No amendment in the rate during the period of execution of the contract, will be accepted.**
12. The Performance Security will remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier/Contractor including warranty obligations.
13. The Bidder should have at least two years prior experience in dealing with such items/work, as the case may be, and financial standing.
14. The Bidders for the contract for supply of Food stuff i.e provisions, vegetable, Non-Veg items, Bakery items should have valid registration under Food Safety and Standard Act 2006/2011.
15. **Tenders, which do not comply with the above conditions, are liable to be rejected.**
16. These terms and conditions of tenders are to be signed by the contractor and returned with the tender.


