- 05. E.M.D should be submitted separately with the tender document by DD in favour of Jawahar Navodaya Vidyalaya, Malappuram Payable at SBI VENGARA
- 06. The terms and conditions should be duly signed by the tenderer.
- 07. The rates quoted should be inclusive of all taxes and F.O.R at Vidyalaya Store and valid up to 30.04.2022.
- 08. The items supplied should be of proper quality, pure, undamaged and fit for use. All the items shall be subjected to inspection and the acceptance or rejection by the Principal JNV Malappuram or any other person authorized by him/her on his/her behalf.
